I/WE HAVE READ THE FOLLOWING TERMS & CONDITIONS AND AGREE TO BE BOUND BY THEM AS WITNESSED BY MY/OUR SIGNATURE(S) BELOW.

- I/we apply for a cardlock operating card(s) (the "Card") of the local or system-wide type, as indicated above, for the purchase of petroleum fuel from the Armstrong Regional Cooperative ( the "ARC") or any cardlock in the CO-OP<sup>®</sup> Cardlock System.
- 2. I/we agree to complete and sign the necessary charge account application forms, New Customer Account & Credit Application.
- If my/our application is accepted, I/we agree to read and be bound by the terms and conditions of this Cardlock User Agreement. My/our use of the Card indicates my/our acceptance of the terms and conditions.
- 4. At the discretion of the ARC, I/we agree to pay \$6.00 for each replacement Card and I/we authorize the ARC to charge the costs to my account.
- 5. For all fuel I/we receive from the ARC's dispensing equipment, I/we agree to pay the price set by the ARC for my account at the time fuel is received from the ARC cardlock. Similarly, for all fuel I/we receive from any other CO-OP<sup>®</sup> System cardlock dispensing equipment, I/we agree to pay the price listed on the dispensing equipment at the time OR the price set for casual users of that cardlock at the time I received the fuel.
- I/we agree to comply with the credit policy of the ARC and to pay my/our account with the ARC and any interest on it in the manner described in the ARC's credit policy as it may exist from time to time.
- 7. I/we understand that the Card and the dispensing equipment are for the restricted used by trained cardholders only, and that the ARC's dispensing equipment is not open for the use of the general public.
- I/we have received instructions in:
  a) the means of activating the ARC's dispensing equipment.

b) the proper operation of the dispensing equipment:c) the location and proper use of the emergency shut-off switches

- and the fire extinguisher. I/we agree not to leave the ARC's dispensing equipment
- 9. I/we agree not to leave the ARC's dispensing equipment unattended at any time while it is being operated; to accept responsibility for controlling sources of ignition; and not to dispense fuels into containers which do not comply with fire regulations or any other regulations that may apply.
- 10. I/we agree to indemnify and save harmless the ARC from and against any and all claims, liabilities, demands, damages, and causes of actions, and all costs and expenses of investigating and defending same, arising from or in any way connected with the use of the Card or its dispensing equipment or from injury to person or property, including death.
- 11. I/we agree that I/we will not disclose by any means, to anyone other than the individuals I/we have authorized, the Personal Identification Number (PIN) assigned to me by the ARC.
- 12. I/we understand that I/we may terminate this agreement at any time by returning to the ARC all of the Cards issued under this agreement or by giving written notice to the ARC.
- 13. I/we understand and agree that any violation of this agreement by myself, or by any of the individuals I/we have authorized, shall entitle the ARC to immediately and without notice terminate this agreement and the privilege of using the ARC's dispensing equipment.
- 14. I/we will not purchase dyed fuel in a province where I/we do not have a dyed fuel purchasing permit. If such a purchase is made, I/we understand that I/we will be charged the clear fuel price (inclusive of all taxes). I/we also understand that this may result in prosecution under the applicable provincial fuel tax act(s).
